

DIRECTIONS

Location 1 & 4
 From the intersection of Hwy 8 and Hwy P in Potosi (Traffic light across from McDonalds)
 South on Hwy P (14 miles) to Hwy C
 Right on Hwy C (4.1 miles) to Hwy Z
 Right on Hwy Z (2.1 miles) to Brazil Rd
 Continue Straight (2.5 miles) to Spectator Parking

Location 8 & 12
 From the intersection of Hwy 19, 32 & 72 in Salem
 South on Hwy 19 (4.5 miles) to Hwy 8
 Left on Hwy 8 (8.4 miles) to County Rd 5380
 Right on County Rd 5380 (1.7 miles) to Spectator Area

Location 9 & 13
 From the intersection of Hwy 19, 32 & 72 in Salem
 North on Hwy 19 (15.1 miles) to Hwy TT
 Right on Hwy TT (1.3 miles) to County Rd 4020
 Left on County Rd 4020 (4.4 miles) to Spectator Area

Location 10
 From the intersection of Hwy 19, 32 & 72 in Salem
 East on Hwy 32 (15.9 miles) to County Rd 4330 (0.3 miles past Howes Mill / Old Mobile Gas Station on right)
 Left on County Rd 4330 (1.0 miles) to Spectator Area

Location 6 - Admission Fee Required
 Access Closed at 8:50AM
 From the intersection of Hwy 19, 32 & 72 in Salem
 North on Hwy 19 (1.5 miles) to Hwy 68
 Left on Hwy 68 (3.8 miles) to Hwy U
 Left on Hwy U (3.3 miles) to County Rd 3180
 Left on County Rd 3180 (1.1 miles) to Spectator Area

SPECTATOR REGULATIONS

Regulations permit spectators only at authorized spectator points.
 NOTE: Any spectator found to be in an unsafe or unauthorized location will be asked to move.
 Anyone that does not follow the instructions of a rally official will cause the event to be halted and the stage canceled.
 When parking near a spectator area, park on the right side of the road with the nose of your car facing away from the spectator area. Please obey any no parking signs so we have a safe event. Parking can fill up, arrive early.
DO NOT PARK ON THE HIGHWAYS.
